JUDGMENT UPON JURY VERDICT

This action was tried before a jury on April 13, 2026, the Honorable Holly Meyer, Circuit Judge, presiding. *James Turnbough v Dave Campbell and Dawn Campbell, Fulton County Circuit Court, 25CV-24-72* and *Melissa Rogers v Dave Campbell and Dawn Campbell, Fulton County Circuit Court, 25CV-24-73* were consolidated by Order filed December 3, 2025, for trial purposes only. The issue in both cases having been duly tried and the jury rendering its verdict reflected on the Interrogatories numbered one (1) through twelve (12) filed in these cases and incorporated herein by reference word for word.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that in case number 25CV-24-72, Plaintiff James Turnbough shall have and recover judgment against Defendant Dave Campbell in the amount of Two Hundred Thousand Dollars (\$200,000.00) and against Defendant Dawn Campbell in the amount of Two Hundred Thousand Dollars (\$200,000.00) for a total of damages awarded to Plaintiff James Turnbough in the amount of Four Hundred Thousand Dollars (\$400,000.00) which separate judgments shall bear interest at a rate equal to the Federal Reserve primary credit rate in effect on the date on which the judgment is entered plus two percent (2%) per annum.

The jury apportioned responsibility for the defamation and resulting damages as to Plaintiff James Turnbough, Fifty percent (50%) to Dave Campbell and Fifty percent (50%) to Dawn Campbell.


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in case number 25CV-24-73, Plaintiff Melissa Rogers shall have and recover judgment against Defendant Dave Campbell in the amount of Two Hundred Thousand Dollars (\$200,000.00) and against Defendant

Dawn Campbell in the amount of Two Hundred Thousand Dollars (\$200,000.00) for a total of damages awarded to Plaintiff Melissa Rogers in the amount of Four Hundred Thousand Dollars (\$400,000.00) which separate judgments shall bear interest at a rate equal to the Federal Reserve primary credit rate in effect on the date on which the judgment is entered plus two percent (2%) per annum.

The jury apportioned responsibility for the defamation and resulting damages as to Plaintiff Melissa Rogers, Fifty percent (50%) to Dave Campbell and Fifty percent (50%) to Dawn Campbell.

IT IS FURTHER ORDERED that Defendant Dave Campbell and Defendant Dawn Campbell shall, pursuant to Ark. Code. Ann. 16-66-221, file with the Clerk of the Court on or before forty-five (45) days from the date of this judgment a schedule, verified by affidavit, of all property, both real and personal, and shall specify the particular property which he/she claims as exempt under the provisions of the law.

IT IS SO ORDERED.
