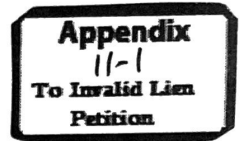


COLOR-OF-LAW PROPERTY DEPRIVATION VIDEO

NATALIE POTTS: It scares me that my friends are being kicked out and we don't know why.

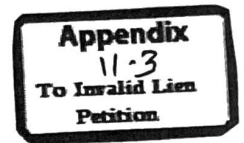
DEBBIE CLUTTER: You'll have to talk to the board about this.
